

# OEA Blue Ribbon Association Award

## 2018–2019 Nomination Guide

The OEA Blue Ribbon Association Award recognizes a local affiliate of the Ohio Education Association for its demonstration of innovative work related to OEAs three strategic priorities. Those priorities are:

1. Build local capacity to be more relevant to members.
2. Leverage the image of education employees to build support for public education.
3. Build OEA as a member resource for professional issues.

Local associations presented with the Blue Ribbon Award have shown themselves to be true advocates of public education and its employees. Recipients will receive a monetary award in the amount of \$1,000.

Recipients of the OEA Blue Ribbon Association Award will be honored at the OEA Spring Representative Assembly.

**Current members of the OEA Board of Directors and association staff members are not eligible for this scholarship. In addition, OEA Awards and Scholarship Committee Members are not eligible for two years after completion of service on the committee to apply or to be nominated.**
