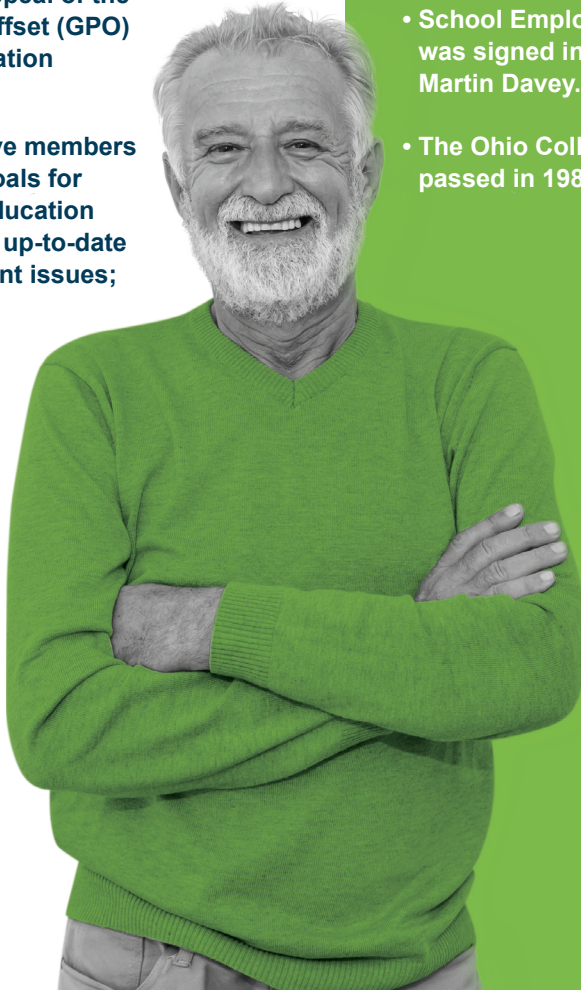
WE WORK FOR YOUR FUTURE

- OEA-R is Ohio's only retired association affiliated with the National Education Association (NEA) and offers a unified membership with NEA and OEA, that is over 3-million members strong.



DID YOU KNOW...

- OEA-Retired is a unique community within the Ohio Education Association (OEA) supporting pre-retired and retired educators.
- OEA began in the early 1900's and was originally known as the Ohio Teacher's Association.
- OEA lobbied the state legislature to establish a liberal retirement program for public school teachers that became the STRS Bill in 1919 and signed into law by Governor James Cox.
- School Employees Retirement System (SERS) was signed into law in 1937 by Governor Martin Davey.
- The Ohio Collective Bargaining Bill was passed in 1983.
- OEA-R represents 10 OEA Districts and is an affiliate of the Ohio chapter of the Alliance for Retired Americans (ARA). Members in each of these Districts often meet to socialize, discuss current issues and learn from others in their area.
- Through a statewide network of over 120,000, members can volunteer in locally based programs that help make their communities stronger.
- OEA-R members can participate in national, state, and regional conferences and seminars that provide relevant and meaningful content to retired educators.
