- RA Location and Start/End Time The RA will be held in person on Friday, May 10, at 6:00 p.m. and on Saturday, May 11 at 9:00 a.m. We anticipate the RA will conclude by approximately 7:30 p.m. on Friday and approximately 3:00 p.m. on Saturday.
- RA Parking Pass and Delegate Credentials There are other large events taking place so delegates who are day parking should arrive as early as possible! <u>Delegates will receive a parking pass (with a</u> <u>map) in the mail with their Delegate Badge/Credential just before the RA.</u> Overnight guests receive a parking discount at the Chestnut Street Garage.
- RA Delegate Registration Delegates must complete the first step via the online registration form in advance. Then, upon arrival, all delegates MUST also register/check in one time at the GCCC in room A110 on Friday, May 10, from 5:00 – 7:30 p.m. or Saturday, May 11, from 8:00 – 10:00 a.m.

- Elections / Voting There will be secret ballot voting on C&B changes and any contested statewide positions at this RA during the 90-minute voting and lunch break.
- Seating by OEA District All OEA districts will have designated seating on the floor of the RA.
